





# CALL FOR SELECTION OF STUDENTS PARTICIPATING IN INnetCAMPUS PROGRAM

The INnetCAMPUS program will be carried out with the financial support of the Erasmus + program of the European Commission.

It is a combined action of ONCE Foundation, as coordinator of the Project, the Artesis Plantijn University College Antwerp (Antwerp, Belgium), the University of Granada (Spain) and the University of Lisbon (Portugal).

# **CALL'S OBJECTIVE**

It is intended for young students with disabilities who are attending Compulsory Secundary Education or High School (or their equivalents according to their country of origin) so they can learn and live first-hand the university experience. Students will stay on college campuses for five days in one of the three partner universities in: Belgium, Portugal and Spain.

This programs' goals are to prevent early school dropout, promote the access to college of young people with disabilities, promote the international mobility of this group of students, and to help European universities identify improvement opportunities on its campuses, so that they are better equipped to provide an inclusive university education, and equal opportunities for all students.

This programme allows the participation of 45 students in the European Inclusive Campus, INnetCAMPUS, funded by the Erasmus+ Programme of the European Union, where intensive programmes including academic and cultural dissemination, sports and other leisure inclusive activities will be developed. This is aimed at bringing these young people closer to the University, providing a chance to get a first-hand insight into the educational, vital and professional growth opportunities offered by university life.

The 45 positions will be distributed as follows:

- 15 positions for one week stay in the inclusive campus in the University of Lisbon Law School (Portugal): <a href="http://www.fd.ulisboa.pt/">http://www.fd.ulisboa.pt/</a> (From the 3rd to the 9th of July, 2016, including days of travel)
- 15 positions for one week stay in the inclusive campus in the Artesis Plantijn University College of Antwerp (Belgium): <a href="www.ap.be">www.ap.be</a> (From the 28th of August to 3rd of September, 2016, including days of travel)
- 15 positions for one week stay in the inclusive campus of the University of Granada (Spain): <a href="www.ugr.es">www.ugr.es</a> (From the 24th to the 30th of July, including days of travel).













In each of the inclusive campuses they will be living together with 10 students with disabilities from other nationalities for one week (five from Belgium and five from Portugal), full board in a university dorm. They will also live with 10 more students (both with and without disabilities).

Any support, personal assistants and supervisors that the students may need will be provided by each University. Trip expenses will be covered by the project.

#### **SUBJECT**

This programme is addressed to Belgian, Portuguese and Spanish students with disabilities in their last compulsory period of High School or taking Vocational Training courses.

Requirements for the selection:

- 1) Being a student with disabilities enrolled in the 2015-2016 academic year in Baccalaureate or in Vocational Training courses, and ranging in age from 15 to 18.
- 2) Being in possession of a legal disability certificate.
- 3) English language skills (B1, Common European Framework of Reference, CEFR).

#### **APPLICATION PERIOD**

# OFFICIAL RESOLUTION

The official resolution will take place within a maximum period of five calendar days starting from the day after the completion of the application period, notifying parents and guardians via email and telephone.

# **SELECTION CRITERIA**

# 1. Type of disability:

The selection will be made so that all types of disability are represented. Candidates must be holding an official disability certificate.

#### 2. Gender balance:

Gender equality will be taken into account to form the groups of participants.













# 3. Risk of school dropout

Special vulnerability situations will be taken into account, such as: the type and degree of disability, unfavourable social or family environment, rural environment, etc.

# 4. Specially appreciated:

- Official certificate of English language B1, CEFR (5 points).
- Cover letter (25 points).
- Academic record (25 points): the academic performance from the academic year 2013-2014 will be assessed, as well as the opinion of the centre.
- Active involvement in persons with disabilities' interest groups (20 points): the students' participation in cultural and leisure associations will be viewed favourably.
- Distance from the place of residence to the university centres (25 points): students coming from rural environment and living far from the University Campuses will be favoured.
