Dear Ladies and Gentlemen,

First of all, I would like to thank Marie for the intermediary work between us and you.

We have been discussing with the European Disability Forum how we could present good practices to the representatives of national authorities who deal with the enforcement of bus and coach passenger rights and to the representatives of the bus and coach industry about how to make this mode of transport more accessible for people with disability or reduced mobility, and we wanted to present examples of good cooperation between organisations representing disabled people and national/regional authorities or public transport companies.

We will have a meeting with the national authorities in Brussels on 26 April (Tuesday) afternoon the Commission's Conference Centre.

We would like to invite the representatives of Atingo and TEC to present us the results of their good cooperation:

- We would be grateful if you could give a 15 min long presentation which would be followed by questions from other participants
- We can provide translation from/to English, French and German so participants from Atingo and TEC could speak of course in French
- Our intention in principle is to show good practices that are not so difficult and expensive to implement in other Member States, but we are also interested in the more general aspects of your cooperation.
- The audience will be mostly generalist public servant who might not be very familiar with the technical aspects of accessibility.
