# **Web Accessibility Directive**

Directive 2016/2102 on web accessibility – Marco Marsella Public sector bodies & associations of public sector bodies. Number of exceptions: exclude broadcasters, include NGO proving services to the public (espcialy to PmH), excludes schools but not their websites.

Harmonised standard, reporting.

Additional requirements:

- Feedback mechanism: users of website can comment If there is for ex. An issue with disability
- Enforcement mechanism: organization in every member state to enforce elements of the directive
- Support training, awareness acting and stakeholders consultation

#### Timeline:

- directive published end 2016,
- 23/08/18 directive into national legislation.
- '19: websites created after 23/09 should be accessible, 1 year later (2019) every website should be accessible
- o Commission will review and give feedback; monitoring methodology.
- Shadi Abou-Zahra World Wide Web Consortium (W3C)
  - Perceivable, Operable, Understandable, Robust: high level principles, success criteria.
- EDF toolkit Alejandro Moledo
  - Feedback & complain mechanism

Exceptions based on disproportionate burden: cost benefits, taking into account frequency and use of website/app.

How enforcement mechanism should work out: do we want penalties, should there be a new body to do this and how this can be fit for this purpose. Organisatations should be involved and consulted. Talk about this with national governments.

- We need to act as soon as possible: contact your government, try to be informed
- We need to inform PmH of the different mechanisms of this directive. Feedback & complain mechanisms should be clear to PmH.
- Raise awareness to the general public. They need to work on their website, it takes time to do this, to be ready on time (2019)

# Case presentations on the transposition of the Directive

- Denmark
- Spain

Legislation was already very advanced. Government is drafting a rolyal degree on accessibility. But there are sill some tings missing

- Disproportionate burden: asked some should be accessible in any way
- Obligation for public sector for a specific time
- Exemptions: exclusion broadcasters, should be enforced in the global website or interface. Still not accepted

European Pillar of Social rights website: should be accessible.

- Slovenia

Bill has past.it was very limited. Lacked ambition.

Include higher education in the bill, failure to include the public broadcaster.

Advice: start early, lobby threw different ministries.

Lithuania

Building better relations with government to be better involved. Closely collaborate with member organisations.

Different degrees of dialogues and involvement with government. Discussion about costs: repeati is should not be considered that way but as an investment: in inclusion, in sustainability and in the implementation of the CRPD.

It would be good for them to include private companies, accessibility act is coming and it covers private sectors and e-commerce services.

  Should be able to get accessible formats. Challenge of corking with org family members. Cannot speak on behalf of the PmH. = violation of the rights in accordance to having their legal capacity (applause ©)

#### Structural funds

- Budget Reduction on Cohesion policy: include all structural funds important for PmH, inclusion,...
- Every year the comminssion gives recommendations to conoutries on how to do national reforms. Usual economic considerations, rarely tackle non dicrimintations and human rights issues.
- Europe social fund plus: used to implement the pillar of social rights. Element in pillar: omh have equal acces to employment
- Regulations for the funds will be released and published next week!

Tuesday we expect a regulation not only regulate the European social funds an regional development funds, used for infrastructure across Europe, new funds, asylum and migrations fund

- Inclusion and switch from institution based toe community based care

# <u>Link between EU funds and economic governance - Marius Vascega (EC)</u>

- Pmh 1/6 in EU.
- Tool: structural funds and cohesion policy
- Economic governance: European Semester: annual growth survey, various monitoring obligations and functions from the commiddios, the member states
- 2014 first integrated: possibility for the EC to request the reprogramming or even expansion of the funds if they are not used for the purposes we have in economic governance. Linkage extended to all the funds.
- Ex ane conditionality
- Horizontal principles included
- Try to include more social targets into the economic governance.

#### Since 2014

- 17/11/17 pillar of social rights

- Social scoreboard: allows to compare and put certain benchmarks. Allows to integrate social policies better into the economic governance process.
- The new MFF (M? financial framework)

When we only speak about conditionality's between EU funds and ecomioic government process, there is a limit. It is not only conditionality's, it is more about the link. Linking hopefully will beter be used wealthier and better inclusion of PmH in EU.

- Nadia: add general comment 5 right to live independently. States cannot use puclic or private funds on institutions (renovationg,..)
- France: 7% vermindering, gevaarlijk voor social plicy. Belang van streamlining
- Remaks on conditionalities: is neccesairy. But not the only ting we need to look at. Structural reforms programme. More active each year. Importance of blending, widening.
- ⇒ Campaign that ALL funds are inclusive. Proposal to add: if the executive committe EDF realizes there is a need for a pan EU campaign to save the structural funds. Protests.

Vervolg over PmH assessment

- International classification of disability of WHO

- Medical assement
- Voorstel aan EDF om een working group te organiseren om guidelines voor te bereiden
- Don't evaluate people, evaluate what we create for people!
- Being ambitious, cultural modal. Relates with design for all. Responsibility to the creater to make it as inclusive as possibl.
- Check lists don't work! More accidents with guidelines than without them (because it was placed in the wrong why)
- Disability assessment should be as scientific objective as possible and socially acceptable. It should not be disability benefits driven
- NDL: privatization of assessment is going quite rapidly
- If the assesent is used to cut, we must be very careful!
- Because of these additional assessment procedures recovery is jeopardazzied. Can be psychologically traumatizing.

### European accessibility act and complimentary accessibility legislation

- Successful in including accessibility in sectorial legislation dialing also with audio visual services and electronic communications. Binding requirements for audiovisual media service providers, basically TV channels public and private to make services accessible.
- Revision of the telecom legislation we managed to includes provisions for PmH as considered as a universal service.
- Accessibility act:
  - Crucial to advocate on national level!

Political and religious affiliation is mentioned in the text.

# **Update on EDF Youth Committee**

Kamil goungor – comes from the independent linving. New in youth committee.

Engage more young people, AGA is not representative in vergelijk met het aantal jonge mensen er zijn in de samenleving. Trust youg people.

Discriminations because you are young: PmH that's young 2x s difficult to get employed than other PmH (for which it is already very difficult). Because of for ex. Lack of experience.

#### President EDF:

- Using a rotation system to bring during the mandate until 2021 all members, not at once, all members of the youth committee to the AGA.
- Kamil will take part in the board, the social policy and inclusion committee.
- Propose the next GA next year we allocate a session to the youth committee to present issues to the AGA. Training of delegates of youth issue.
- Propose that next year one of the public hearings permanent study group of disability rates of eco and social committee together with EDF address youth issues

Continue working on how young people with intellectual disabilities can engage in youth committee.

# **Evaluation of the meeting**

#### Any other business

- Complaint against France to the social and eco rights to the council of Europe. Failed PmH to have adequate support. Process will be lengthy, probably be 2020 before we have a result.
- Oviedo protocol. EDF wrote to the council of Europe asking them to withdrawl the protocol. Bioethics committee. Draft got worse. Meeting about this last week, EDF didn't go, because we do not agree. A letter to explain the absence and reseans to be against this protocol. Toegether with mental health Europe.

# Video die dit toelicht.

- Bioethics committee zal hiermee doorgaan omdat zee en mandaat hebben van council of ministers. We moeten via onze eigen overheid gaan & send letters tot he council of europe. Enkel als de council of europe zich terugtrekt zal de bioetic stoppen ,want nu denken ze dat ze hiervoor het mandaat hebben.
- o Vraag om de brieven mee te verspreiden. ENUS: we need your support.
- ESPD: Capa committee werd het ook besproken. Veel onenigheid hierrond. Maar member states dit not take positions. We need to convince 1 or 2 member states to stop it. Expert group stopped working. No body anymore to keep an eye on this action plan.
- Polish protesters in polish parliament. Will be discussed iextensively in executive committee. Open letter, send with information received from member of polish parlemaint. No direct contact with protesters.cross checked with eco and social committee. Actions from police were disproportioned. Er was veel reactie op gekomen. Brief heft veel aandacht gekregen in Polen.
