1) UNCRPD : alternative report 2-3 of the BDF on the implementation of the UNCRPD by Belgium. Preparation and redaction with all BDF members, submission to the Committee, defense in Geneva during the Country Briefing on 28-29 March 2019. Follow-up to the List of issues published by the Committee on 30/04/2019.

2) CEDAW : alternative report of the BDF. Meeting with Professor Tina Goethals (RUGent) about the content of her study on sexual violence against women with a disability in Flanders. Presentation of the BDF working process to the EDF AGA on 02/05/2019. Preparation and redaction of the alternative report with all BDF members, submission to the Committee. Follow-up to the List of issues published by the Committee on 18/11/2019. Exploitation of the content as basis of a submission to Greivio in the follow-up framework of the Istanbul Covenant (CoE).

3) Follow-up of the developments of the European Disability Card : its implementation in Belgium and follow-up of the EU process in order to increase the number of Member states using it in the future.

4) EU elections process. Writing of the BDF political memorandum for the EU 2019 elections and submission to all political parties. Organization of a debate with candidates from all political parties. Action for an improved accessibility of the election processes. Follow-up to the EU elections.
