We are doing our best. Now, as I pointed out, we depend on our member organisations and they don't know who within their members are EDC holders...

- Up to now, I sent the links to 29 persons
- It appeared that 2 of them misunderstood EDC and "EU parking card" : it leaves 27 potential respondentsThe big problem is the "-30" groups : only one woman identified and no man...
- Subgroup "women 30-50" = too many potential respondent (7)
- Subgroup "women +50" = too many potential respondent (8)
- At the beginning I was planning to send links only to 5 by subgroup, but there was the risk that some would not answer: I have no means of control, even less of pressure!

Thank you for your answer. I didn't work during this weekend so I'm answering you now.

Your explanatory notes are welcome. Nevertheless, the Belgian Disability Forum asbl (BDF) are highly interested in the success of the EDC and have a good knowledge of the process in Belgium and at EU level as well.

Our main concerns were the time constraints and respect of GDPR. Within this frame it was impossible to meet your request.

Receiving no answer to our requests, we didn't insist on our member organisations anymore on searching for persons willing to answer. Still I could transfer the links to 14 persons whose coordinates were sent to me by 2 member organisations of the BDF (2 on 18). Three of the volunteers sent me back an e-mail saying that they did answer.

Now that I have a short additional delay, I will contact the other organisations in order to have them identifying the needed profiles that are still missing. This process is not as easy as one could imagine, as our organisations are not aware of who among their members are EDC holders, evenmore who could enter in the missing profiles of your requested cohortes.

We will do our best within the 7 extra days, as Thursday and Friday of this week are holidays in Belgium...

About the accessibility of the questionnaire, two respondents sent me a feedback :

- one is a blind person. He faced no problem at all
- one is the assistant of a person with slightly intellectual disability. She pointed out that the
  phrasing in French made it uneasy to explain (translation problems, maybe). Another thing: for
  some questions, the person would have liked to have a 'not applicable' option. For instance, she
  doesn't practice any sport activity and would have appreciated such an option for these
  questions...

we are sorry for our late reply, we're all in a very stressful and complicated situation these days. First of all, in the attached file "survey\_introduction\_NL\_FR\_DE", there are some useful explanatory lines we hope could help to explain why it's important to fill in the survey.

For what concerns the accessibility of the survey platform, Google Form, the file

"google\_forms\_vpat.pdf" has a detailed assessment of the platform's accessibility. To summarize it, for the basic question types, it is ok, but not when images and sound inputs are integrated. So, as long as there are only simple question types (single, multiple choice, open text), the survey is keyboard-readable.

Finally, we can certainly provide you with extra days to send out the invitations to the survey. Let's set the new deadline to May 26th.

Thanks again for your collaboration in spreading this survey to help our study.
